Terms and Conditions

1. Participation in the Photo Contest organized by the embassy of France in Suriname and in Guyana involves acceptance of its terms and conditions. Any dispute about these terms and conditions is not possible.
2. Participants are invited to send photos and a description of the photo (no more than 150 words in English or Dutch) in one of the following categories: Nature, Culture and Built heritage.
3. Anyone who wishes to participate in the photo contest may submit their photo (s) from *November 6th 2018 until and including January 6th 2019 at 00.00 hrs*. Each participant can send up to 2 (two) photos per category. The photos will be judged by a jury set up by the embassy of France in Suriname and in Guyana.
4. All submissions must be in before January 6th 2019 at 00.00 hrs. and can be send at : cad.paramaribo-amba@diplomatie.gouv.fr

5. From all entries, a selection will be made per category. This selection is determined by the jury. The winning results will be announced on the website and the Facebook page of the embassy and the cooperating partner organization SHATA.
6. From all categories 2 winners will be chosen. The jury set up by embassy of France in Suriname and in Guyana always has the final decision on the outcome of the Photo Contest.
7. Participation in the Photo Contest is free and open to all non-professional photographers.
8. Adding, editing, or deleting certain photo elements that change the content of the photo is not allowed. Merging photos or making a collage is also not allowed.
9. The embassy of France in Suriname and in Guyana reserves the right to terminate, discontinue or change the Photo Contest at its sole discretion and without notice, and / or to modify the Terms and Conditions and / or any prizes without being liable for damages to the participants in the Photo Contest.
10. The winners and winning pictures will be published on the website, in social media, in newsletters and the winning pictures will be used by the embassy of France in Suriname and in Guyana. By participating in this Photo Contest, winners authorize the embassy of France in Suriname and in Guyana to use his / her name as well as the winning promotional / promotional photos related to this Photo Contest.
11. Photos may not have been published before in other Photo contests.
12. Submitted photos may not contain insulting, rude or degrading elements that affect third party privacy or which are offensive or obscene, or possibly commit to infringements or crimes. It is forbidden to submit vulgar, hateful, threatening, (child) pornographic and other sexually explicit photos.
13. Plagiarism and other abuse are not accepted.
14. The pictures should have a minimum image size of 1200 x 1200 / A4 printable size, 72 dpi. The maximum file size allowed is of 3 MB. The pictures should be supplied as a jpg file.
15. Both color and black and white pictures are allowed.

16. The following information should be provided at submission of the photo: First name, last name, date of birth, gender, email address, home address, phone number and city.
17. The personal data required for participation will be the property of the organizer (s) and will not be provided to third parties. The data will be recorded in a file.
18. Participation is open for everyone aged 18 years and over. Participation is excluded for employees from the French embassy in Suriname and any co-organizing partners or anyone who is in any way directly or indirectly involved in the organization of this photo competition.
19. The embassy of France in Suriname and in Guyana shall not be liable for the participant's incorrect data (name, email address, etc.), for any lost entries and / or network, hardware or software malfunctions that result in limited, delayed or lost data from the participant.
20. The embassy of France in Suriname and in Guyana reserves the right to disqualify and / or withdraw a participant if the participant in any way violates these Terms of Use or otherwise acts illegally against the embassy of France in Suriname and in Guyana and / or cooperating third parties.
21. The embassy of France in Suriname and in Guyana also has the right to exclude a participant from participation in the Photo Contest if it appears that the participant has provided incorrect, incomplete or misleading information or otherwise commits or attempts to commit fraud.
22. If there is a prize to be won, it will be stated during the promotion of the Photo contest. Each participant or submitted e-mail address will only be eligible for one prize and each prize is unique and will be in the name of the respective winner.
23. The prize is not transferable, redeemable for cash or another prize.
24. By participating in the Photo Contest, the participant agrees to cooperate in any promotional activities related to the Photo Contest (including the award of the prize).
25. After the results of the Photo Contest are known, the prize winners will be notified personally. They will be informed about the details of the transfer of the prizes.
